

Interested?

All students interested in earning a bachelor's degree at Nova Southeastern University may be eligible to receive credit through the prior-learning program. Students may transfer up to 90 degree-applicable credits toward their degrees. Students must initiate any and all prior-learning requests, including examination for credit, prior to completing 24 credits at NSU. Approved prior-learning credits will be reflected on the student's transcript after 12 credits are successfully completed at NSU.

Cost

- Transfer credit and CLEP review: free
- Standard grant evaluation: \$25 per credit for the evaluation process
- Portfolio evaluation: \$45 per credit for the evaluation process

Transfer Services at Nova Southeastern University



Looking to transfer to NSU?

The Office of Transfer Evaluation Services (TES) can help! TES provides services to undergraduate students like you who wish to receive credit for coursework or educational experiences outside the classroom.

Transfer Credits

Nova Southeastern University (NSU) will transfer a maximum of 90 degree-applicable credits toward a degree, including credit for the College-Level Examination Program (CLEP), proficiency exams, and prior experiential learning. NSU will transfer courses for which a student has earned a grade of *C* or higher. Remaining credits and at least 50 percent of credits in the student's major must be earned at NSU in regular academic offerings.

Credits will be transferred based upon receipt of official and/or unofficial transcripts and having at least a provisional admit status to the university. Transfer students must provide final official transcripts from all previously attended colleges for full admit status. Students will be advised to take courses at NSU based on the completed transfer evaluation.

Transfer students who have earned an Associate in Arts degree or 60 credits as of 1992 from a Southern Association of Colleges and Schools (SACS) accredited institution and are in good academic standing, as defined by the transfer institution, shall be admitted to NSU with junior standing.



Prior Experiential Learning

Use your past achievements to help design your future by earning college credit for skills and training you already have.

NSU is committed to serving undergraduate students who possess skills and training acquired through an experiential learning background. Many of the skills taught in an undergraduate program can be, and oftentimes are, learned outside the classroom. If you have college-level skills then the prior experiential learning program may be for you.

Colleges use a variety of systems to gauge student knowledge. The system utilized by Nova Southeastern University is called prior learning. This is a comprehensive procedure for assessing prior college-level learning for undergraduate students. The purpose of this assessment is to award college credit for learning experiences that are judged appropriate by faculty members and other professional evaluators.

Credit can be derived from several sources.

- transfer credit from other accredited colleges and universities
- CLEP/DSST/NYU Proficiency Exam
- full portfolio course challenge
- standard grants

Foreign Credentials

Courses completed at foreign institutions must be evaluated and translated to English by an approved foreign credential evaluation service. A course-by-course evaluation with grade point average is required.
