1. Approval of May 15, 2002 Minutes

2. Humana and Wellness Committee Update

In response to the questions that were raised at the May 15 meeting, Dr. Chenail contacted Dr. Doug Buck for some updated information regarding Humana. Dr. Chenail shared Dr. Buck's responses:

a. When is the next meeting of the Wellness Committee?

They are in process of scheduling the next Wellness meeting, but they are having

difficulty with everyone's schedule. The next meeting is now slated for July.

b. When is the next meeting of the Insurance Committee?

The Health Insurance Committee meeting is scheduled for Wednesday, June 12th.

c. If NSU adopts a new wellness plan, will positive results on the part of employees participating help to lower our insurance costs and/or will the program just be added to the lists of benefits employees will receive?

The intent of the wellness program is to hopefully translate into employees becoming healthier and thus reducing the "usage" of our insurance benefits thereby reducing our claims experience that is a significant factor in our renewal rates. The program "offerings" have not been fully developed so it is difficult to say specifically what will be the components. One component we are looking at is a case management approach that would be voluntary for employees. A case manager would be assigned to those employees who complete a health assessment and would work with the employee individually to improve their wellness. This is a program offered through North Broward Health District at a per employee cost.

d. Besides helping me with these questions, is there any other information, Humana or otherwise, you would like for me to share with the FAC?

Other information is that Holy Cross and Humana discussions are still occurring but no resolution on Holy Cross joining the network. A new Humana President is "in negotiations" with the CEO of Holy Cross. Humana is also in serious discussions with the Cleveland Clinic and are optimistic that they will join the network very soon.

After discussing these points of information, council members raised some additional issues:

- a. Has the Wellness Committee consider the issues of confidentiality?
- b. Would the new wellness program introduced by the College of Dental Medicine be made available for other faculty?
- c. Given that the top five prescriptions are connected with the treatment of stress related symptoms, was the Wellness Committee considering adding meditation and yoga classes?
- 3. Bookstore Contract Update

The new bookstore contract had not been finalized. Dr. Chenail reported that the university was in negotiations with Barnes and Noble. Notification would be distributed upon closure of the negotiations.

4. Travel Office Update

Dr. Chenail reported that he had spoken with Dr. Hanbury regarding the university's assessment of the travel office. Dr. Hanbury stated that the university was still looking

into a number of scenarios regarding travel at the university. One approach had the university contracting out travel service, as is currently the situation. Another approach would have the university operating its own travel office. Another approach would be to utilize commercial sites such expedia.com or Orbitz.com and have employees book their own travel arrangements. Dr. Chenail said he would report back to the council when there is an update on travel.
