



Gift-In-Kind Form

This document ensures accuracy in accepting a gift to Nova Southeastern University, Inc. (NSU). Formal acknowledgment of a gift will be provided by a separate document after acceptance of the gift by NSU.

NSU Information:

- NSU is a 501(c)(3) not for profit corporation; tax ID No 59-1083502.
- All gifts-in-kind must be accompanied by a fair market value estimate of the gift as determined by the donor.
- Gifts-in-kind with an apparent value of \$5,000 (\$10,000 if closely-held stock) or more, require that a qualified appraisal and completed IRS Form 8283 be submitted with this Gift-in-Kind Form, unless the donor will not be seeking a tax deduction.
- NSU requires gifts-in-kind of \$5,000 or more to have the written approval of the NSU Gift Acceptance Committee.
- It will be the donor’s responsibility to ensure that the proper forms are filed with the United States Internal Revenue Service. The donor shall incur all costs for appraisals, if required.
- NSU requires that its Deed of Gift Form be duly executed by the donor for In Kind contributions
- Gifts of Services are not deductible as per IRS
