




### 2025 GENDER STATS

### Application Checklist

- Attend LSAC Law Recruiting Forum or Recruiting Fair. [www.LSAC.org](http://www.LSAC.org)
- Request Information from NSU Law and schedule a visit. [www.law.nova.edu](http://www.law.nova.edu)
- Open an account with the Law School Admissions Council (LSAC). [www.LSAC.org](http://www.LSAC.org)
- Register for LSAC's Credential Assembly Service (CAS). [www.LSAC.org](http://www.LSAC.org)
- Register and take the Law School Admissions Test (LSAT). [www.LSAC.org](http://www.LSAC.org) \*
- NSU Law recommends taking the LSAT before December for scholarship consideration.
- Submit at least two letters of recommendation using the LSAC Letter of Recommendation Service (LOR).
  - 1 LOR must be from an academic source if you are currently enrolled in undergrad or graduated in the past year.
  - If your graduating GPA is below NSU Law's percentiles, one of the required letters should be academic, from one of your professors. If you have been out of school for some time, letters from a work situation can be helpful.
  - Will accept up to three LORs.
- Write and submit a Personal Statement of your original work:
  - that describes your interest in law study,
  - in NSU Law,
  - your skills and qualifications, or
  - otherwise supports your case for admission.
- Submit an additional statement.
  - 1-page document explaining how your life experiences and background may contribute to class discourse and to the enrichment and discussion of coursework and to your future legal career.
- Submit a resumé, attached to your electronic application, that includes updated relevant work and educational experience.

- October:** FAFSA (*Free Application for Federal Student Aid*) Application Opens: **School Code: 001509**

- November:** Admissions decisions will begin to be made.
- December 15:** Scholarship Priority Consideration Date - Opportunities for admission and scholarship consideration are awarded on a first-come, first-served basis.
- February – April:** Admitted Students Events.
- April 15:** First Seat Deposit Deadline.
- May – July:** Admitted and Deposited Student Events.
- May:** Spring graduates finalize your transcripts and submit them to LSAC.
- June 15:** Application Deadline.
- July:** Summer graduates finalize their transcripts and submit to LSAC.
- August:** Orientation and first week of law school.
