IF YES, YOU WILL NEED A 1042-S FORM (ISSUED BY YOUR INSTITUTION) & YOU WILL NEED TO FILE A 1040NR/1040NR-EZ FORM (IF YOU ARE A NON-RESIDENT ALIEN FOR TAX PURPOSES).

*QUALIFIED EXPENSES: TUITION, FEES, & BOOKS ONLY.

IF YOU ANSWERED NO TO BOTH OF THESE QUESTIONS: YOU PROBABLY ONLY NEED TO FILE AN 8843 (IF YOU ARE A NON-RESIDENT ALIEN FOR TAX PURPOSES & HAD NO INCOME IN THE US).

THE VOLUNTEER INCOME TAX ASSISTANCE (VITA) PROGRAM OFFERS FREE TAX HELP TO PEOPLE WHO GENERALLY MAKE \$54,000 OR LESS, PERSONS WITH DISABILITIES AND LIMITED ENGLISH SPEAKING TAXPAYERS WHO NEED ASSISTANCE IN PREPARING THEIR OWN TAX RETURNS.
