Academic advisors or admission counselors must complete the **Tuition and Cost of Living Estimate** worksheet. The Centers or Program Offices may either fax (954-262-3846) or interoffice (mailroom code ISS) the form to the Office of International Students and Scholars.

Before issuing an initial or transfer I-20, the OISS will verify sufficiency of funds by checking the Total I-20 Amount line against the student's financial statement or bank letter. (Bank documentation should not be more than three months old from the application date and must be in U.S. dollars.)

Nova Southeastern University requires payment in full at the time of registration. Non-payment of tuition may prevent a student's ability to register for classes, and failure to register for classes may result in the loss of the student's non-immigrant status.
