# **NSU Multimedia Camp**

## **Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement**

I, \_\_\_\_\_ (“Participant”), hereby acknowledge that I have voluntarily elected to participate in the following activity/trip, **NSU Multimedia Camp** (“Activity”), to be held in and around Nova Southeastern University, from June 18–30, 2018. In consideration for being permitted by the Nova Southeastern University (“NSU”) to participate in the Activity, I hereby acknowledge and agree to the following:

**ELECTIVE PARTICIPATION:** I acknowledge that my participation is elective and voluntary.

**RULES AND REQUIREMENTS:** I agree to conduct myself in accordance with NSU policies and procedures. I further agree to abide by all the rules and requirements of the Activity. I acknowledge that NSU has the right to terminate my participation in the Activity if it is determined that my conduct is detrimental to the best interests of the group, my conduct violates any rule of the Activity, or for any other reason in NSU’s discretion.

**INFORMED CONSENT:** I have been informed of and I understand the various aspects of the Activity, including the dangers, hazards, and risks inherent in the Activity, including but not limited to transportation to and from Nova Southeastern University via private vehicle, common carrier and/or NSU owned vehicle, participation in NSU Multimedia Camp, overnight accommodations, weather conditions, conditions of equipment, facility conditions, negligent first aid operations or procedures, and in any independent research or activities I undertake as an adjunct to the Activity. I understand that as a Participant in the Activity I could sustain serious personal injuries, illness, property damage, or even death as a consequence of not only the NSU’s actions or inactions, but also the actions, inactions, negligence or fault of others. I further understand and agree that any injury, illness, property damage, disability, or death that I may sustain by any means is my sole responsibility except for those occurrences due to the NSU’s negligence or intentional acts.

**RELEASE AND WAIVER OF LIABILITY:** I, on behalf of myself, my personal representatives, heirs, executors, administrators, agents, and assigns, **HEREBY RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE NSU**, its governing board, directors, officers, employees, agents, volunteers and any students (hereinafter referred to as “Releases”) for any and all liability, including any and all claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorneys’ fees), arising from any injury, property damage or death that I may suffer as a result of my participation in the Activity, **REGARDLESS OF WHETHER THE INJURY, DAMAGE OR DEATH IS CAUSED BY THE RELEASEES, UNLESS THE INJURY DAMAGE OR DEATH IS CAUSED BY THE RELEASEES’ NEGLIGENCE OR INTENTIONAL ACTS, AND REGARDLESS OF WHETHER THE INJURY DAMAGE OR DEATH OCCURS WHILE IN, ON, UPON, OR IN TRANSIT TO OR FROM THE PREMISES WHERE THE ACTIVITY, OR ANY ADJUNCT TO THE ACTIVITY, OCCURS OR IS BEING CONDUCTED.** I further agree that the Releasees are not in any way responsible for any injury or damage that I sustain as a result of my own negligent acts.

**ASSUMPTION OF RISK:** I understanding that there are potential dangers incidental to my participation in the Activity, some of which may be dangerous and which may expose me to the risk of personal injuries, property damage, or even death. I understand that there are potential risks as a consequence of, but not limited to: participation in (SPECIFY activity), travel to and from (SPECIFY) via private vehicles, common carriers, and/or NSU owned vehicles, weather conditions, overnight accommodations, facility conditions, equipment conditions, first aid operations or procedures of Releasees, and other risk that are unknown at this time.

**INDEMNITY:** I, on behalf of myself, my personal representatives, heirs, executors, administrators, agents, and assigns, agree to hold harmless, defend and indemnify the Releasees from any and all liability, including any and all claims, demands, causes of action (known or unknown), suits, or judgments of any and every kind (including attorneys' fees), arising from any injury, property damage or death that I may suffer as a result of my participation in the Activity, **REGARDLESS OF WHETHER THE INJURY, DAMAGE OR DEATH IS CAUSED BY THE RELEASEES OR OTHERWISE, UNLESS THE INJURY DAMAGE OR DEATH IS CAUSED BY THE RELEASEES' NEGLIGENCE OR INTENTIONAL ACTS.**

# **Nova Southeastern University**

## **Office of Residential Life and Housing**

### **Rules, Regulations, and Policies**

Once you have read the following items, please initial that you understand and will comply with the following rules, regulations, and policies:

1. NSU is a smoke-free campus. Smoking is not allowed in the residence halls or on any other NSU property \_\_\_\_\_.
2. Alcoholic beverages may not be brought into the residence halls or on any other NSU property \_\_\_\_\_.
3. Firearms or any item considered to be a weapon is not to be brought into the residence hall or any NSU property \_\_\_\_\_.
4. The possession, promotion, distribution, use, or sale of illegal substances is a violation of NSU policy. This includes the trafficking and serving of substances represented as drugs to other persons. This also includes paraphernalia for illegal drug use \_\_\_\_\_.
5. No alteration, damage, or removal of NSU property from the rooms or common areas should occur. Any changes to set-up will result in a \$10.00 per hour charge for reset and/or cost of replacement. Campers may be assessed a financial charge of \$100.00 per occurrence if their participants move furniture out of the rooms \_\_\_\_\_.
6. NSU staff members have the right to inspect the rooms and all other areas in the assigned Residence Hall at any time \_\_\_\_\_.
7. Windows should be kept closed or a \$50.00 charge per occurrence will be assessed \_\_\_\_\_.
8. The camper's parent(s)/ guardian will be assessed a charge of \$75.00 per lost key and \$25.00 per lost access card after check-out. No camper may mail in or drop off lost keys/cards for charge reversal \_\_\_\_\_.
9. No one shall behave in a manner that harasses any other person or further serves to disrupt the peace and/or comfort of other occupants. This includes, but is not limited to:
  - Any words or acts, whether intentional, unintentional, negligent, or as a product of disregard for the safety, rights, or welfare of others, which can cause physical or emotional harm, or which intimidate, degrade, demean, threaten, haze, or otherwise interfere with another person's right to comfort \_\_\_\_\_.
  - Loud or aggressive behavior which disrupts the orderly functioning of NSU or any member of the NSU community \_\_\_\_\_.
  - Any conduct or action that constitutes a threat to the health or safety of the NSU community of those occupants in assigned Residence Hall \_\_\_\_\_.
10. Occupants shall at all times be responsible for the conduct of their guests, in connection therewith; the organization shall also be responsible for the conduct of all guests \_\_\_\_\_.
11. No pets or animals of any kind are allowed within any residence hall \_\_\_\_\_.
12. No family housing is available at this time children are not permitted to stay overnight in the residence halls at Nova Southeastern University \_\_\_\_\_.
13. The camper and occupants shall comply with all directives and requests of a NSU representative acting in the performance of his/her duties \_\_\_\_\_.
14. No one shall enter, or attempt to enter, any room, building, motor vehicle, or other form of property without proper authorization or consent from NSU \_\_\_\_\_.
15. No fire alarm shall be unnecessarily set off. Anyone found tampering with fire extinguishers or alarm equipment, blocking fire exits, or impeding traffic flow in any other manner will be subject to a \$500.00 fine \_\_\_\_\_.

16. The following items shall not be brought into rooms or into the common areas of the assigned Residence Hall: barbecue grills, multi-outlet electrical plugs, candles, incense or other open flame items, non-approved extension cords, halogen lamps, combustible materials, gasoline, or flammable petroleum powered vehicles \_\_\_\_\_.
17. Lounges, study rooms, reception lobbies, and other common areas are provided for the comfort and convenience of all participants. Furnishings in outside and inside common areas may not be removed from those areas. Participants, who take these items to their rooms or elsewhere, on or off campus, are subject to a \$100.00 fine. Charges for loss or damaging not able to be assessed to a particular individual will be charged to the camper. Charges for broken lounge furniture will result in fines to the camper.
- Campers who are identified as being responsible for damages to residence hall furnishings, structures, or equipment will be charged the appropriate labor, material, and administrative costs necessary to reimburse the office of residential Life and Housing for the expenses involved.
- These charges, however, may vary due to unforeseeable changes in the price of materials and labor. Other damages to the assigned Residence Hall shall be charged according to cost of repair or replacement \_\_\_\_\_.
18. The following procedures must be followed in case of fire:
- When a fire alarm is sounded, evacuate the assigned Residence Hall immediately and close the door when leaving the room. Do not take the elevator – you may get caught in a power outage. There are stairwells located in each residence hall to assist with emergency evacuation. When outside of the Residence Hall, remember to make your way to the designated assembly point and do not interfere with the Town of Davie Fire Department, Town of Davie Police, and any other authorities \_\_\_\_\_.
19. The procedures in the NSU Campus Safety and Traffic Handbook, available online at [www.nova.edu/publicsafety/forms/campus\\_safety\\_handbook.pdf](http://www.nova.edu/publicsafety/forms/campus_safety_handbook.pdf) must be complied with if a Hurricane Warning and/or other severe weather conditions are declared by the U.S. Weather Bureau \_\_\_\_\_.
20. NSU is not liable for any loss or damage to the camper's and/or the occupants' property while on NSU's premises \_\_\_\_\_.
21. NSU reserves the right to evict any occupant or guest without refund when he or she violates any of these rules or regulations \_\_\_\_\_.
22. This Contract shall be governed by, enforced and construed in accordance with the laws of the State of Florida. With respect to any action instituted by either party relating to this Contract, the parties accept the exclusive jurisdiction of the courts of the State of Florida, and agree that venue shall lie exclusively in Broward County, Florida \_\_\_\_\_.
23. NSU shall not discriminate against any employee or participant in the performance of the duties, responsibilities and obligations under this agreement because of race, age, religion, gender, national origin, marital status, disability or sexual origin \_\_\_\_\_.
24. Each person by signing this agreement on behalf of either party individually warrants that he or she has full legal power to execute this agreement on behalf of the party whom he or she is signing and to bind and obligate such party with respect to all provisions contained in this agreement \_\_\_\_\_.
